

Sarang Korean School Release of Liability and Indemnity Agreement

I, the undersigned, hereby represent that I am the parent or legal guardian of _____ (name of minor, hereinafter referred to as the "child"), born on ____/____/____ (birth date of the child), and acknowledge that I have voluntarily applied to participate in Sarang Korean School Program (hereinafter referred to as the "program") sponsored by Sarang Korean School, Inc. (hereinafter referred to as the "school").

I fully understand that participation in the program involves a certain degree of risk and can be physically, mentally, and emotionally demanding. I have carefully considered all risks involved and have given consent for the child to participate in the program and to receive rides to and from the school, if applicable. I also understand that the child is expected to abide by all rules and regulations governing conduct for the program. I hereby assume all risks in connection with my child's participation in the program including but not limited to personal injury and death, and hereby completely release the school, its representatives, agents, affiliates, officers, directors, servants and employees from ALL LIABILITY for any injuries, death or damages and from any claim or legal action by me, any parent or guardian of the child, the child, anyone on behalf of the child, and by the child's estate, heirs and assigns arising in any way from my child's participation, including any claim based on NEGLIGENCE. In addition, I agree to defend and indemnify and hold harmless the school from any and all claims arising from the child's participation in the program.

In the event of an emergency requiring medical treatment for the child in the opinion of anyone working at the school, I authorize the school to call for medical care or to transport the child to the appropriate clinic or hospital. I agree that upon turning the child over to the undersigned or their designees or to any ambulance or other medical transport, medical facility, clinic or hospital, the responsibility of the school shall be totally fulfilled and the school shall not have any further responsibility for the child. I further agree to pay ALL CHARGES associated with such medical care and related transportation for the child. As the parent or legal guardian of the child, I am responsible for the health care decisions on the child's behalf and am authorized to consent to the services to be rendered.

I have carefully read the foregoing RELEASE OF LIABILITY AND INDEMNITY AGREEMENT and understand its contents. I acknowledge and understand this is a full and complete release of liability and indemnity agreement, that it includes any and all claims by the child, me or anyone else on the child's behalf for any reason, INCLUDING NEGLIGENCE, and that I am contractually agreeing to these terms FREELY, FULLY AND WITHOUT RESERVATION in exchange for the right to have the child participate in the program.

Parental/Guardian Consent for Minors (under 18 years old ONLY):

I AM AWARE THAT THIS AGREEMENT IS LEGALLY BINDING AND THAT I AM RELEASING LEGAL RIGHTS BY SIGNING IT. I certify that the undersigned is the parent or legal guardian of the child. I consent to the child's participation in Sarang Korean School Program and certify that I have read and fully understand the meaning and consequences of the foregoing release.
